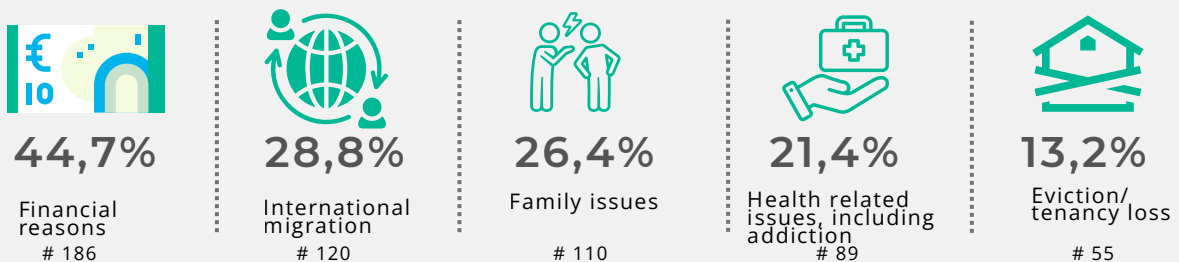

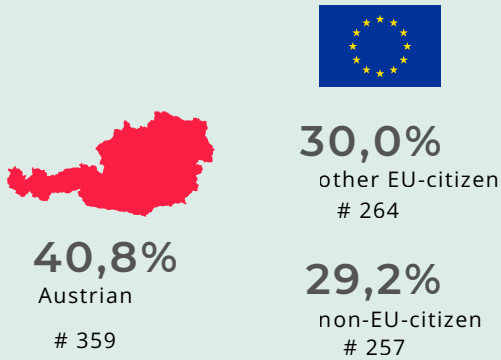

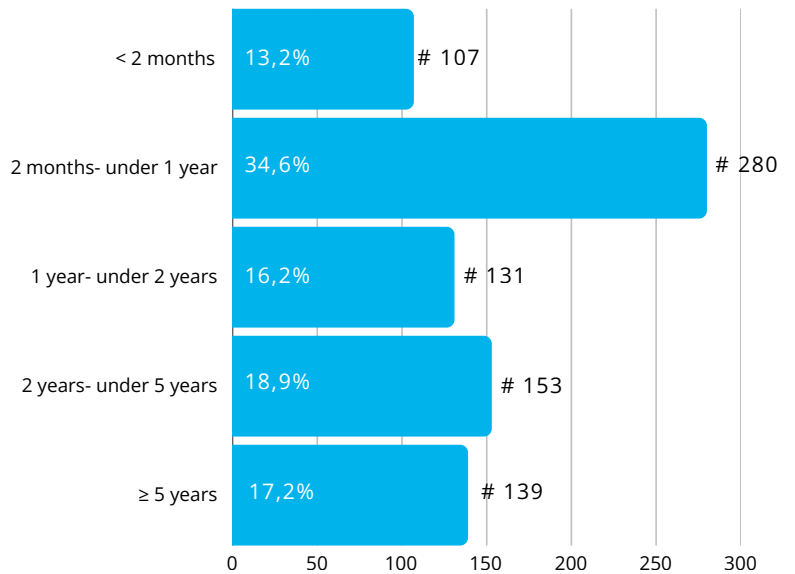

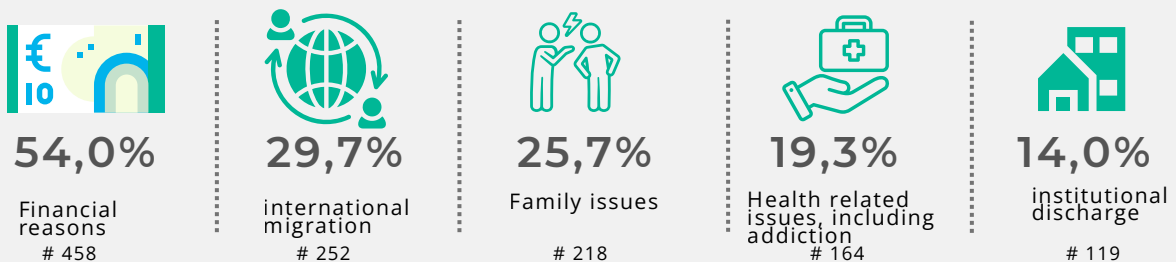

SUMMARY

The province of Salzburg has a long-standing tradition of conducting comprehensive service-based counts among a large network of services for PEH, social welfare and social counselling services, hospitals and psychiatric institutions as well as services for persons to be released from prisons and services for asylum seekers to be released from government-sponsored housing. Yearly service-based counts have been conducted since 1995, and results have been mapped to the ETHOS Typology. Typically, an online survey tool is used, and data is entered by caseworkers alone based on existing client data. In 2025, the City of Salzburg decided to take part in the EU Homelessness Counts project, to include the place of stay according to ETHOS Light as well as the compulsory variables mentioned in the data overview in the online survey, and to evaluate and communicate the results specifically for the city area. This resulted in a detailed overview of the extent and profile of homelessness in the City of Salzburg according to ETHOS Light.

The local network of organisations for PEH – represented in the Forum Wohnungslosenhilfe Salzburg – and the long-standing tradition of conducting extended service-based counts were clear advantages during the preparation phase. Also, a complete online questionnaire using the online survey tool Unipark / Tivian already existed and was adapted to the provisions and goals of the EU Homelessness Counts. Finally, great expertise and experience among the persons central to the organisation of the count in previous years facilitated planning and implementation. Since most of the services involved in the count were familiar with the counting procedure, less training and communication effort had to be undertaken. However, since the housing market in the City of Salzburg is particularly tight, the results for the city will support local housing strategies and inform political decision-making.

Just like the years before, the 2025 comprehensive service-based count relied on a broad network of services for PEH, public institutions and social welfare services, hospitals and psychiatric institutions, institutions for persons with substance abuse issues, services for former inmates and services for asylum seekers to be released from government-sponsored housing. Questionnaires were filled out by caseworkers alone based on existing client data, and results for the City of Salzburg were filtered from the results of the count in the entire province. Questionnaires were only available in German language. The reference date was October 1, and the counting period was October 1 to October 31. As organisations with different backgrounds and clientele were involved, all ETHOS Light categories could be reached. ETHOS Light 1, 2, and 3 could be extensively covered via outreach teams, day centres, night and emergency shelters, as well as temporary and transitional housing offers. Persons in ETHOS Light 4 could be reached through a limited number of hospitals, psychiatric institutions, health services for persons with substance abuse issues, services for former inmates and services for asylum seekers to be released from government-sponsored accommodation. Persons in ETHOS Light 5 and 6 could be reached through the services mentioned above as well as a large network of social counselling and support services, job counselling services, social welfare offices, services for persons with psychological support needs, etc.

SUMMARY

Results for the ETHOS Light categories 1-3 indicate that almost 45% of 452 PEH counted could be attributed to ETHOS Light 1, while the rest was distributed almost evenly between ETHOS Light 2 and 3. 80% of PEH were male, and nearly 90% lived alone. Around 40% of persons included in the survey were Austrian citizens, and 43% were EU citizens. 66% had permanent resident status, 22,5% had temporary resident status, and 10% were reported as undocumented residents. Interestingly, over 75% of persons included in the survey were above 30 years of age, with persons between 30-49 years and 50-64 years as the two largest age groups. Financial reasons, family issues, and international migration were reported as the most common reasons for homelessness.

All in all, the comprehensive service-based count in the City of Salzburg can be described as a success that was facilitated by the great expertise and experience among the persons involved in the planning and organisation of the count in previous years. However, integrating the existing survey with the goals of the EU Homelessness Counts and mapping the results to the ETHOS Light framework required substantial effort from all parties involved. The existing network of services for PEH provided a fruitful environment for a consistent rollout in the City of Salzburg and beyond. Comparable results among other cities taking part in the EU Homelessness Counts and reliable numbers on homelessness and precarious housing provide a firm basis for political decision-making and for identifying current housing needs. As Salzburg has one of the tightest and most expensive housing markets in Austria, current numbers can contribute to creating sustainable housing solutions for the most vulnerable social groups.
